**AN ORDINANCE PROVIDING FOR THE CONTINUED DEFERRAL
OF SEWER IMPACT FEES FOR
CERTAIN RESIDENTIAL DEVELOPMENT PROJECTS**

The Board of Directors of the Sacramento Regional County Sanitation District ordains as follows:

SECTION 1. Section 10 of Ordinance No. SRCSD 0079 is hereby repealed.

SECTION 2. This Ordinance was introduced and the title thereof read at the regular meeting of the Board of Directors on November 12, 2003 and on November 12, 2003 further reading was waived by the unanimous vote of the Directors present.

This Ordinance shall take effect and be in full force on and after thirty (30) days from the date of its passage, and before the expiration of fifteen (15) days from the date of its passage it shall be published once with the names of the members of the Board of Directors voting for and against the same, said publication to be made in a newspaper of general circulation published in the Sacramento Regional County Sanitation District.

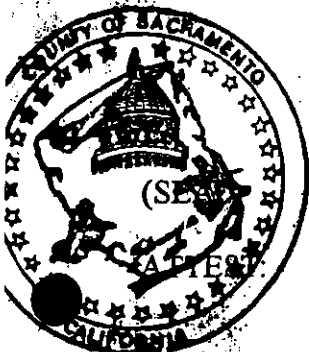


